**1.2 Product Information**

**Product Name:** Sofia RSV FIA (Catalog #: 20242, 20260, and 20291)

**Recommended Use:** The Sofia RSV FIA employs immunofluorescence for detection of respiratory syncytial virus (RSV) nucleoprotein antigen directly from nasopharyngeal swab and nasopharyngeal aspirate/wash specimens from symptomatic patients. This qualitative test is intended for use as an aid in the rapid diagnosis of acute RSV infections in pediatric patients less than 19 years of age. A negative test is presumptive, and it is recommended these results be confirmed by virus culture or an FDA-cleared RSV molecular assay. This assay is for in vitro diagnostic use only.

**Components:** Kit is composed of individually pouched test cassettes, reagent tubes, reagent solution, sterile nasopharyngeal swabs, pink fixed volume pipettes (large), clear fixed volume pipettes (small), RSV positive control swab (swab is coated with non-infectious RSV antigen) and negative control swab (swab is coated with heat-inactivated, non-infectious Streptococcus C antigen).
