Intended Use: Affinity Purified Goat Anti-Mouse FGF-23 (N-term) Antibody (polyclonal). This component is for professional use only. Not intended for human or animal diagnostic or therapeutic uses.

Sodium azide (<0.1%) is present as a preservative. Avoid disposal of the product down sanitary or industrial plumbing systems. Sodium azide may react with lead and copper plumbing to form highly explosive metal azides.

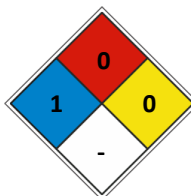
